		Prof. Gerry Boyle has been Director of Teagasc - Ireland's Agriculture and Food Development Authority - with responsibility for agriculture and food research, extension and farmer education for 10 years. Teagasc's annual budget is €180 m and it has a staff of 1200 plus 280 students undertaking doctoral research. Prior to becoming CEO of Teagasc, Professor Boyle was Head of the Economics Department at the National University of Ireland, Maynooth and during the mid 1990s he was Economic Adviser to the Irish Prime Minister. He has also served as a senior consultant with the World Bank in Eastern Europe and Central Asia. Professor Boyle is a member of the Royal Irish Academy and a recipient of the Chevalier Des Palmes Academiques from the Government of France.

Brendan Dunford originally from a farming background in Co. Waterford, joined the Burren in 1998 to complete a doctoral study on the impact of farming on the heritage of the Burren, later published by Teagasc as 'Farming and the Burren'. He led the award-winning BurrenLIFE Project (2005-2010) and currently manages the Burren Programme, a locally-led, farmer-centered, results-based, agri-environment scheme. Along with his late wife Ann O'Connor, Brendan co-founded Burrenbeo Teo and is secretary of its successor, the Burrenbeo Trust, Ireland's only landscape-based charity which focusses on fostering stronger connections between people, their places and their role in caring for them. Brendan is a former board member of the Heritage Council of Ireland, Ireland's EPA Advisory Committee and former Director of the European Forum on Nature Conservation and Pastoralism. He is an Ashoka Fellow for Ireland in acknowledgement of his work in supporting entrepreneurial practice in rural sustainability.

Kevin is a postdoctoral researcher based at the Rural Economy and Development Programme (REDP), Teagasc. Kevin is currently working on the Department of Agriculture funded FOROWN project. This project explores the factors that influence private forest owners' engagement in forest management, and in particular, the role played by advisory services, knowledge transfer events and the social networks of owners. Kevin has previously worked as a lecturer at the Plant and Agri-Biosciences Centre in the National University of Ireland Galway and has held the role of Chief Economist with the Irish Farmers' Association (IFA). She teaches farmers the skills to help improve profitability and technology adoption on their farms in grassland management. Catherine graduated with a degree in Agricultural Science from University College Dublin, and completed a Masters. Her study focused on the attitude of farmers and advisors to the promotion of a low cost grass based system on beef and sheep farms. Previously she was a Beef BETTER Farm programme advisor working with beef farmers in the North-West of Ireland operating different beef systems on various land types. She comes from a beef and sheep farming background in Co. Roscommon.

Trevor is a Principal Research Officer in the Agricultural Economics and Farm Surveys Department. He is a member of the FAPRI-Ireland modelling team which undertakes economic analysis of agricultural markets and policy issues affecting the agri-food sector. He has 20 years' experience in modelling dairy, pigs and input markets. Policy issues he has examined have included Brexit (2016, 2017), CAP Reform (2012), WTO Trade reforms (2001, 2006, 2008) the Medium Term Review of the CAP (2003, 2004) and the Fischler reforms (1999, 2000). He also studies the environmental impacts of the agricultural sector, particularly the area of Greenhouse Gas emissions and is a member of the Royal Irish Academy Climate Change and Environmental Sciences Committee. He has worked extensively on a range of EU funded international projects exploring issue associated with the economics of the agri-food sector.

The analysis of the implications of Brexit for the Irish agri-food sector is an important component of the research programme of Teagasc's Rural Economy Development Programme.

Sven Anders is Professor of Agricultural Economics in the Department of Resource Economics and Environmental Sociology at the University of Alberta. His research focuses on the economics of agri-food supply chains. The goal is to develop strategies that allow farmers to take advantage of the latest production technologies while helping to mitigate-farm greenhouse gas emissions.
